Record of Risk Assessment Reviews

Background

This risk assessment will consider the risks to RCCG, The Fountain church members, ministers and others while the coronavirus is leading to Covid-19 infection in the general community in the UK.

Note: This risk assessment only addresses hazards directly related to physical exposure to Coronavirus/Covid-19.

Hazard - Coronavirus (COVID-19), which is spread in minute water droplets that are expelled from the body through sneezing, coughing, talking and breathing. The virus can be transferred to the hands and from there to surfaces. It can survive on surfaces for a period after transfer (depending on such things as the surface type, its moisture content and temperature).

Risk Consequence - The vast majority of people who become infected with COVID-19 will have mild to moderate symptoms which will self-resolve, and will not require further NHS treatment. Whilst Covid-19 illness can be fatal.

The **severity** of Covid-19 remains **high** until a vaccine or treatment is available.

Likelihood is based on the likelihood of transmission, which may lead to one or multiple fatalities.

If personal hygiene, cleaning measures, and social distancing measures (in accordance with government guidance) are followed and all very high risk/very vulnerable (shielded) persons remain at home and high risk/vulnerable persons (see NHS lists) either join online service from home or away from other people, likelihood of transmission leading to a fatality will be low.

The overall risk assessment below considers scenarios and possible control measures on the basis that **nobody** involved in the Sunday service /face-toface activities is a very high risk (shielded) or high risk individual (shielded persons **must** only worship online from home. A person living in a household where somebody is very high risk (shielded) should also join the service online from home.

General Control Measures

Procedures in place to ensure all members and visitors register on arrival at the church.

Reminders to all members via communications /website and poster displays to:

- Frequently wash their hands with soap and water for 20 seconds and dry thoroughly and the correct hand washing technique.
- Use a tissue or elbow to cough or sneeze and use bins for tissue waste ('catch it, bin it, kill it').
- Not touch their mouth, eyes and nose.
- Implement normal personal hygiene

Church workers / cleaners working on the premises may be at risk of contact with members who are infected with the coronavirus or church members attending Sunday service, bible study and other church activities.

KEY CONTROLS OR PROCESSES IN PLACE TO MITIGATE RISK

Church members to avoid close face-to-face contact or touching.

Physical contact, such as handshakes, hugs, pat on the back etc. to be avoided

Plastic protection screens to be issued to all usher on the duty roster at and during all church activities while on the church premises.

Vulnerable church members - In accordance with government regulations, all vulnerable members with a pre-existing health condition are at a higher risk of contracting COVID-19 which may have a significantly increased adverse effect on their health.

KEY CONTROLS OR PROCESSES IN PLACE TO MITIGATE RISK

All vulnerable church members are to continue online service, and the church members who are over the age restriction put in place by the Government should be encouraged to stay at home and take part in the service through the online services

Church volunteers with family members in high-risk categories have been instructed to inform their pastors about their condition and attend the online service.

Personal hygiene - Poor personal hygiene standard poses a risk of passing or spreading the infection.	The importance of good personal hygiene has been communicated to all Church members. Particularly the need for regular, thorough hand washing and the avoidance of touching eyes, nose or mouth, if their hands are not clean
	Church members are advised to use alcohol-based hand sanitiser, soap and gel are provided
	Church members are advised that disposable tissues should be used when coughing and sneezing
	Freestanding hand sanitiser will be placed at access points all around the Church Premises
	As the alcohol-based hand sanitiser falls under a COSHH item. Church members who use this to disinfect their hand should avoid touching their face until the sanitiser dries out due to the risk of irritation if it touches the eye
	If the cleaning substance mistakenly touches the eye and the eye irritation persists then the Church member should seek medical attention
	Church members diagnosed with skin conditions are advised to use soap and observe the 20 seconds rule of hand washing

KEY CONTROLS OR PROCESSES IN PLACE TO MITIGATE RISK

Money counters and ushers - The virus can stay on some items longer than 24 hours, to avoid the risk of ill health as a result of the transfer of Coronavirus and other pathogens through crosscontamination after contact with offerings and offering envelopes.

The use of offering envelopes for offering should be minimise and online or paperless given will be encouraged

Where envelopes are in use, ushers and money counters will use PPE during the processing.

Bank details for donation will be displayed on media boards

A well-aerated room will be designated for the counting of offerings while those involved will use the PPE supplied by the Church

Offering baskets will not be passed around rather the usher will place the offering baskets at locations that can be easily reached.
